The Digital Director's Office: a must in times of increasing duties and regulatory pressure

How is the work of Independent Directors evolving?

The role of independent directors has changed a lot over the last few years. I would even say, the role has turned 180 degrees: from a tacit assessor to an active contributing actor.

Independent non-executive directors (INEDs) are facing higher demands in Luxembourg – quite in line with the trends observed in the US and the UK. Globally, this is due to the growing necessity to set standards for corporate governance. Locally, this trend is also coupled to the tremendous increase of funds domiciled in Luxembourg, especially AIFs during the last decade. Accordingly, regulatory requirements related to functions and oversight are strengthened and thus putting additional pressure on boards. Indeed, processes and definitions related to governance have been formalized over the last years, including a clearer delineation of the role of INEDs and Boards. Until recently, the Independent Director was quite often more of a silent participant in board meetings – if an INED was appointed at all. In today's evolving landscape, INEDs are expected to have a strong understanding of corporate governance principles and practices. They should actively participate in board meetings, provide oversight on strategy, risk management and others, and ensure compliance with relevant regulations and laws. Committed, open-minded, experienced, and modern team players form the new generation of INEDs. What could be considered a side job in retirement a few years ago has evolved into a full-time job that requires the right qualification, mindset, skills and attitude.

What does this development mean for Independent Directors?

An independent director, who wants to do his job properly must always be up to date. He/she must be informed

about the latest regulatory changes and have a holistic picture of the company/structure, processes, and specifics. This can be very demanding for someone who is not involved in the daily business and above that has a weak own manual director's office organisation. I speak from my own experience. It is not always easy to keep track of everything, you have to be very well organised yourself.

- Could I answer ad-hoc questions regarding special events during the financial year?
